MINUTES Regular Meeting OCTOBER 28, 2019

Motion to approve the open session minutes from the Board of Commissioners meeting held on September 23, 2019 was made by Commissioner Dunne and seconded by Commissioner Russell. Upon roll call, all Commissioners voted "Aye".

EXECUTIVE DIRECTOR REPORT

The Executive Director gave monthly report to commissioners and residents in attendance and highlighted all completed and future projects. Chairman Jampel asked for clarification that the garbage chute cleaning went from once a year to twice a year. Mr. Naszimento said that is correct. Chairman Jampel also asked if the speeding on Ovation Way still continued with the speedometer present. Resident's in attendance said they did not notice any change in the way people drove down Ovation Way.

Motion to approve BHA operating payment checks #26180 through #26183 was made by Commissioner Russell and seconded by Commissioner Dunne. Upon roll call, all Commissioners voted "Aye".

Motion to approve BHCDC RAD Operating Payment Checks #1255 through #1279 was made by Commissioner Dunne and seconded by Commissioner Oliver. Upon roll call, all Commissioners voted "Aye".

COMMITTEE REPORT

Judy Henry recapped the meeting of the Holiday Party Committee and also discussed the Thanksgiving feast that Epiphany Church serves at the Housing Authority.

NEW BUSINESS

Resolution 2019-22 awarding a contract for elevation maintenance services.

Motion to approve Resolution #2019-22 awarding a contract for elevator maintenance services was made by Commissioner Russell and seconded by Commissioner Dunne. Mr. Naszimento discussed the solicitation for the elevator maintenance services. Upon roll call, all Commissioners voted "Aye".

PUBLIC INPUT

Mr. Robert Fisk, George Conway resident said that several machines in the laundry room aren't working properly, he also mentioned that the Community Room carpet should be cleaned or replaced.

Ms. Ginger Oppenheimer, George Conway resident requested that the Community Room bathrooms be repaired or renovated.

Ms. Patricia Allen, Forge Pond resident asked if there would be a smoking shelter built. Chairman Jampel said we tried to have a shelter built but ran into setbacks with the Building Code Department and the Housing Authority is stilling looking into other options or solutions.

Many residents in attendance spoke about the smoking in apartments or the smell of smoke in the hallways. A brief discussion followed. Mr. Naszimento reiterated that apartment inspections were taken place and reminded tenants that the Brick Fire Bureau will be inspecting units as well.

Council Liaison, Art Halloran said he noticed several lights out around the Flag Pole. Mr. Naszimento said he will have maintenance repair the lights.

Chairman Jampel thanked everyone for their thoughts, comments and concerns.

Motion to open the meeting to the public was made by Commissioner Russell and seconded by Commissioner Oliver. Upon roll call, all Commissioners voted "Aye." The meeting re-opened to the public at 7:30PM.

• Resolution #2019-24 authorizing the execution of an inter-local service agreement for shared executive director services.

Motion to authorize execution of an inter-local service agreement for shared executive director services with Secaucus Housing Authority for 2020, at an annual rate of \$65,000, with all other terms the same as the 2019 contract was made by Commissioner Russell and seconded by Commissioner Oliver. Upon roll call, all Commissioners voted "Aye".
